A corporation is a company, a group of people or an organization authorized to act as a single entity (legally a person) and recognized as such in law. Early incorporated entities were established by charter (i.e. by an ad hoc act granted by a monarch or passed by a parliament or legislature). Most jurisdictions now allow the creation of new corporations through registration.

How do I form a business corporation? A business corporation may be formed by filing a Certificate of Incorporation pursuant to Section 402 of the Business Corporation Law.

Application for Reservation of Name Domestic and Foreign Corporations. An individual or an existing domestic or foreign corporation may reserve a corporation name for use at a later date by filing an Application for Reservation of Name pursuant to Section 303 of the Business Corporation Law. The filing of an Application for Reservation of Name will reserve a name for 60 days.
